The journal only publishes unpublished (original) articles of high scientific quality, which have received positive evaluations from two anonymous expert reviewers. To be published, each article proposal undergoes a double-blind peer review and is subjected to anti-plagiarism detection. Published articles are considered original and may relate to fields such as language sciences, discourse analysis, literature, linguistic grammar, communication, etc. As a scientific journal intended for emerging scholars (students), researchers, and academic staff, Akofena aims to be a platform for the dissemination of advanced scientific research and to promote scholarly exchange..

For its *20th varia issue to be published in Jun 2026*, Akofena is launching a call for papers covering all aspects of Language Sciences, Literature, Languages, Communication, and related disciplines. Article proposals may be written in French, English, Spanish, or German..

Minimum length: 08 pages, maximum: 14 pages, single line spacing. Page numbering should be in Arabic numerals, placed at the bottom right of each page.

Some Guidelines for Authors

For a theoretical or fundamental research article:

- Introduction (justification of the topic, research problem, hypotheses/scientific objectives, approach)
- Structured Development
- Conclusion
- Bibliographic References (only sources cited in the article)

For an article based on field research :

- Introduction
- Methodology
- Results
- Discussion
- Conclusion
- Bibliographic References

Article Presentation

- First page:

The article must include:

- The title
- The first and last names of the authors
- Their institutional affiliation
- Their ORCID ID (<https://orcid.org/signin>)
- Their email address
- Their WhatsApp number (if possible)

- Abstract:

Should not exceed 350 words. It must be concise and highlight the core of the analysis.

- Keywords:
- A maximum of five (05).
- Résumé (French abstract):

Also limited to 350 words, presenting the essential content of the analysis.

- Mots-clés (French keywords): A maximum of five (05)

Translate the title of the article into English when the article is written in French. For any other language besides French, the translation of the title, abstract, and keywords into French is required.

- **Introduction:** Should provide enough background information to set the context in which the study was conducted. It must enable readers to assess the qualitative value of the study and evaluate the results obtained.
- **Body of the text:** The different sections of the body should appear in a logical order (e.g., 1.; 1.1; 1.2; 2.; 2.1; 2.2; etc.). The introduction, conclusion, and bibliography are not numbered.
- **Footnotes:** Should not refer to bibliographic references but to additional information.



- **Citations:** Are integrated into the text and must follow APA citation standard. [<https://www.revueakofena.com/normes-editoriales/>]

AI Detection

Since the implementation of the system to detect texts generated by artificial intelligence, about 70% of submitted contributions unfortunately cannot be evaluated due to an automated writing rate sometimes reaching nearly 100%.
